### Schedule of Fees for Maritime Agents' Services 2024

**Article (1):** This schedule shall be referred to as the "Schedule of Fees for Maritime Agents' Services for the Year 2024" and shall be effective as of the date of its approval by the Board of Directors of the Jordan Shipping Association.

**Article (2):** For the purposes of this schedule, the following terms and expressions shall have the meanings assigned to them below unless the context indicates otherwise:

- Association: Jordan Shipping Association.
- Maritime Agent: A natural or legal person registered as a company or establishment and licensed by the competent authority to engage in maritime agency activities on behalf of the maritime carrier, vessel owner, operator, or charterer, within the scope of their agency agreement with any of the aforementioned parties or their representatives, and in accordance with the applicable laws, regulations, and instructions.
- **Fee:** The remuneration collected by the maritime agent pursuant to the provisions of this schedule in return for services provided to vessels and cargo.

**Article (3):** The maritime agent shall collect the following fees for general cargo, bulk cargo, and heavy lift cargo:

# Article (4): The maritime agent shall collect the following fees for Ro-Ro cargo:

- C. The maritime agent shall collect a delivery order issuance fee of 5 to 10 JOD per bill of lading.
- D. The maritime agent shall receive a 50% discount on Ro-Ro fees if a cargo booking agreement is in place.
- E. The maritime agent representing the cargo shall receive a 20% discount on Ro-Ro fees when cargo is loaded between two or more shipping lines, provided that the transporting line is the shipper and the agent of the shipping line is the consignee on the bill of lading.
- F. The maritime agent shall not collect any fees for transshipment cargo.
- G. A fee of 40 JOD shall be charged for manifest or bill of lading amendments for non-agents.
- H. A fee of 25 JOD shall be charged for manifest amendments for maritime agents.
- I. A 30% surcharge shall be applied to all fees in Articles (3) and (4) for hazardous cargo transported on Ro-Ro vessels.
- J. A bill of lading issuance fee for export cargo shall range from 10 to 15 JOD per bill of lading.
- K. Cargo loaded on Ro-Ro units, whether for import or export, shall be charged according to its classification and type.

Article (5): The maritime agent shall collect the following fees for containerized cargo:

- B. The maritime agent shall collect a delivery order issuance fee of 5 to 10 JOD per bill of lading.
- C. The maritime agent shall collect a direct loading fee of 20 JOD per container.
- D. The maritime agent shall collect a manifest or bill of lading amendment fee of 40 JOD.
- E. The maritime agent shall collect a bill of lading issuance fee for export cargo ranging from 10 to 15 JOD per bill of lading.
- F. For LCL (Less than Container Load) shipments, the maritime agent shall apply charges based on whichever is greater: weight or volume as per Article (5/A).
- G. The maritime agent shall collect a fee of 10 JOD per delivery order issued for LCL cargo.
- H. The maritime agent shall collect a cargo monitoring fee of 20 JOD per container for follow-up in the logistics village.

Article (6): The vessel agent or feeder vessel agent shall collect the following fees from the maritime line agent who is a member of the Jordan Shipping Association, in the event of loading or discharging containers belonging to the represented shipping line or within a shipping alliance:

A 30% surcharge shall be added to the above fees if the cargo transported in the containers is classified as hazardous materials.

**Article (7):** The fees stipulated in this schedule shall be subject to a 50% discount for services provided to government agencies and the Jordanian Armed Forces.

Article (8): The Jordan Shipping Association is responsible for monitoring and ensuring compliance by maritime agents with the prescribed fees in accordance with the association's bylaws and regulations.

**Article (9):** The Board of Directors of the Jordan Shipping Association reserves the right to review and amend the fees stipulated in this schedule as necessary.
